### **OBLIGATION**

Your Designated REALTOR® (Broker or principal appraiser) is required to pay dues conditional upon your affiliation with their company. If you choose not to submit for REALTOR® membership within 30 days of affiliation, your Designated REALTOR® will be required to pay a NonMember Assessment. As a result of this policy, your Designated REALTOR® may require that all licensees affiliated with their company hold REALTOR® membership as a part of company policy.

# Requirements

# **Dues Obligation**

REALTORS® must renew their membership annually to maintain the use of the REALTOR® trademark and services.

### Policy

Members of the National Association of REALTORS®, the Tennessee REALTORS® and the Southern Middle Tennessee Association of REALTORS® agree to uphold the governing documents and policies of said organizations.

# **Mandatory Training**

Members of the National Association of REALTORS® must submit to regular training on the REALTOR® Code of Ethics and Fair Housing as defined by NAR policy. Current policy requires new members to complete 3 hours of Code of Ethics training and 2 hours of Fair Housing training within 60 days of membership application and then again within specific 3-year cycles as designated by NAR. Cycle deadlinesre. Requirements are subject to change and members must obtain approval from SMTAR before completing course work outside of the association. ### **FORMS**

Your REALTOR® membership gives you access to the Tennessee REALTORS® online real estate forms program called TransactionDesk. TransactionDesk courses are approved for TREC credit. (There is a separate fee for courses!) Forms are under constant scrutiny by a panel of real estate agents and attorneys to ensure they meet the letter of the law.

# REALTORS® Property Resource

Compiles all available data on a property, including data fed from MLS systems willing to provide their feeds and allows you to research, compare and report that information in a beautiful package to your clients.

# Multiple Listing Service (Additional monthly fee, required service \$45/month plus \$250 Software License Fee)

The multiple listing service in our area is a regional service operated by RealTracs Solutions. RealTracs is a statewide service and is expanding its capabilities daily. RealTracs users can share their listing information with 100's of websites across the nation and have valuable benefits such as:

# Lockbox Program

SMTAR has more than 2,000 lockboxes owned by the association in circulation in the Southern Middle Tennessee region that are borrowed by its members. The lockbox program allows a Designated REALTOR® to hold an inventory of lockboxes in their office for their agents to use, or to allow their agents to borrow locks directly from SMTAR. An annual cost to only those companies and individuals using the service has allowed us to maintain this program since 1998. This program is an optional service.
